Child Protection Policy

1. Introduction

a. SenzAgro is committed to creating a safe and protective environment for all children who come into contact with its operations, programs, and activities.

b. The Child Protection Policy aims to prevent child abuse, exploitation, and neglect and to provide guidelines for staff, volunteers, and stakeholders on appropriate conduct and reporting procedures.

2. Policy Statement

a. SenzAgro maintains a zero-tolerance approach to any form of child abuse, exploitation, or neglect.

b. SenzAgro is committed to:

- Protecting the rights and well-being of children involved in its activities.

- Ensuring that children are treated with dignity, respect, and fairness.

3. Scope
